FROM THE NORTH: Leave the M40 at Junction 14. Take the A452 (Warwick bypass) to Leamington. At the roundabout, you can either take the A452 to Leamington Spa, picking up signs to Southam, or you can take the A452 to Banbury, then follow the signs for Harbury and Ufton.

The Club is located 1.5 miles outside of Ufton, on the left hand side of the A425.

FROM THE SOUTH: Leave the M40 at Junction 11 in Banbury. Follow the A422 over two roundabouts. At the third roundabout, take the A423 (Southam Road) and continue until the roundabout outside Southam with the Shell Garage. Take the first right onto the A425. The Club is 1 mile outside of Southam on the right hand side. If you wish to use a Sat Nav, please use the post code CV47 2DL.

BY TRXIN

The nearest train station is Royal Learnington Spa which is 6 miles away (approximately 13 minutes.) This station is on the Marylebone line, but also offers a short connect to Coventry, on the Euston line. Birmingham to Learnington Spa can be achieved in 30 minutes. For direct trains to London Euston, Rugby station is 13 miles from the Club.

IXL EVENTS CENTRE TERMS & CONDITIONS

1. BOOKING TERMS

- Bookings will only be confirmed once both the full deposit is received and the signed booking form.
- We recommend contacting us via telephone at first to provisionally hold your booking. Your provisional booking will be held for 7 days and a 25% deposit needs to be paid during this period. If your booking is made after 1st November the final balance will need to be paid in full, within 7 days. Failure to make the deposit during this period or contact us to let us know otherwise, will result in your booking being automatically released.
- Failure to make the final balance will render your booking void.
- We regret that we are unable to make any changes to your booking, menu choices or drinks order, on the week of your event. The total number of guests for each party night, must be settled in one payment.

2. REFUNDS AND CANCELLATIONS

- Deposits are non-refundable and non-transferable.
- Cancellations can only be made by the party organiser and must be made in writing to the office. We do not accept cancellations over the phone.
- Cancellation charges and refunds will be calculated as follows:
- Any monies lost as a result of cancellations or drop-outs cannot be used for any other goods or services (including but not limited to pre ordered drinks package)
- Cancellation charges are non-transferable.
- The management reserves the right to reallocate places should the party size drop.

3. TICKETS AND TABLE PLANS

- Tickets are not required and will not be provided.
- Due to ongoing changes and configurations, tables will not be allocated until the day before each event. All table plans must be submitted to us by 1st November 2023.

4. BEVERAGES

- Any drink vouchers purchased are non-refundable after the event, can not be exchanged for cash on the night and are only valid for the year as stated on the drinks voucher.
- Should you wish to order a drinks package or purchase any drinks for the table, these must be confirmed and paid for in full by 1st November. Regretfully we are unable to make concessions at the event for guests who have not pre-purchased beverages.
- Customers are responsible for checking their drinks on arrival at the table and must inform a supervisory member of staff with any discrepancies. Refunds or products cannot be claimed after the event.
- Guests may not, under any circumstances, bring their own drinks.
- Drinks not consumed during the event cannot, under any circumstances, be taken from the venue.

5. MENU PRE-ORDERS

- There is a set menu for this event with a vegetarian/vegan alternative. Special dietary menus may be available upon request. Menu choices must be received no later that 1st November.
- If group menu options are not made before the event, the standard menu will be served.
- We reserve the right to make changes to the advertised menu in the event of shortages in the supply of items.
- Only one arrival drink is allocated per person.

6. VENUE/EVENT CONDITIONS

• The customer is responsible for ensuring the good and orderly behaviour of its guests whilst at the Christmas Party and ensure no one will cause any offence, nuisance, damage, disturbance, annoyance, interference or inconvenience to any IXL Events Centre staff.
